Reorganization

Effective March 1, 2024

Reorganization of Suntory Holdings Limited

• At Suntory RTD Company, the Global Strategy Department will be established to transfer some functions to the United States, the most important market, in order to achieve the goal of becoming No. 1 in the world in the RTD category by 2030. In addition, the North America Business Development Department will be established to promote new business development in North America.

In conjunction with this, the Global Strategy & Planning Department will be renamed the Global Development & Operation Department.

Effective April 1, 2024

Reorganization of Suntory Holdings Limited

- The Business Planning Department will be established under the Group Governance Division to promote group-wide planning.
- To come together and address the increasingly significant 2024 logistics problem and work on issues such as Scope 3 greenhouse gas reduction and DX promotion, the functions of the Supply Chain Division will be reorganized into three functional divisions: the Supply Chain Strategy Division, the Procurement Division, and the Supply Chain Innovation and Development Division.
- -The Global Supply Solutions Department, the Strategy Planning Department, and the Supply Chain Digital Transformation Department will be placed under the Supply Chain Strategy Division.
- -The Procurement Planning Department, the Raw Material Department, the Packaging Material Department, and the Logistics Department will be established under the Procurement Division.

- -The Supply Chain Innovation Department, the Supply Chain Sustainability Development Department, and the Supply Chain Quality and Safety Department will be established under the Supply Chain Innovation and Development Division.
- To increase the flexibility of strategy implementation within the Sustainability Management Division, the Corporate Sustainability Department will be closed down and merged into the division's functions.
- To plan and promote strategies related to information, which is an important management resource for the whole Group, and effectively utilize information, the ERP Strategy Department will be established under the Digital Transformation Division.
- In addition, the IT Strategy Department will be renamed the Global IT Department to optimize activities related to the Group's IT across the entire Group.
- The Design Department under the Communication Design Division will be renamed the Design Center to promote global operations and expand into a wide range of domains beyond product design and development.

Reorganization of Suntory Spirits Limited

- To strengthen integrated management across the entire alcoholic beverages business, the company system will be abolished, and the respective functional divisions (Corporate Planning, Logistics, Marketing, and Production) will be reorganized as Management & Brand Management and MONOZUKURI Management. In addition, the departments of Sales & Marketing Company will be reorganized as Sales Management.
- The Business Strategy Division, the Supply Chain Management Division, the Communication Division, the Future Development Department, the Beer Division, the Spirits Division, and the Wine Division will be put in place for Management & Brand Management.
 - -The Business Planning Department, the Human Resources Department, the General Affairs and Risk Management Department, and the Liquor related Government Affairs Department will be placed under the Business Strategy Division.
 - -The Supply Chain Strategy Planning Department, the Supply Chain Planning Department Beer and RTD, and the Supply Chain Planning Department Spirits and Wine will be placed under the Supply Chain Management Division.
 - -The Advertising Department, the Customer Relationship Management Department, and the MUGINONE Promotion Department will be placed under the Communication Division.
 - -The Premium Beer Marketing Department, the Brand Marketing Planning Department, and the International Strategy Department will be placed under the Beer Brand Division.
 - -The HOS (House of Suntory) Global Strategy Development Department, the Whisky Marketing Department, the Liqueur/Spirits/Shochu Marketing Department 1,

- the Liqueur/Spirits/Shochu Marketing Department 2, and the RTD Marketing Department will be placed under the Spirits Brand Division.
- -The Wine Import Strategy Department, the Japanese Wine Department, the Casual Wine Business Division, and the Winery Department will be placed under the Wine Brand Division.
- The MONOZUKURI D&P Strategy Planning Department, the Beer Development & Production Division, and the Spirits, Wine Development & Production Division will be put in place for MONOZUKURI Management.
