This is to notify that Suntory Holdings Limited will be reorganizing group companies and implementing their executive appointments.

Reorganization

Effective January 1, 2026

Reorganization of Suntory Holdings Limited

- In order to support strategic decision-making by management executives and the communication of information inside and outside the Company, a President's Office will be newly established under the Corporate Strategy Division.
- For the purpose of promoting further cooperation with each organization in the Monozukuri Divisions, part of the functions of the Monozukuri People & Culture Division will be reorganized into the Monozukuri People & Culture Department.

Reorganization of Suntory Spirits Limited

- Management functions and brand functions will be reorganized for the purpose of marketing integrated with the liquor business and strengthening the development of products and services aimed at the future.
 - A Management Division will be newly established to strengthen the management functions of Suntory Spirits Limited as a whole.
 - The Beer and RTD Division, the Spirits Brand Division, the Wine Brand Division and the Communication Division will be abolished, and a Beer and RTD Marketing Department, the Whisky Marketing Department, a Global Brand Development Department, the Liqueur/Spirits/Shochu Marketing Department and a Wine Marketing Department will be established under a newly established Marketing Division.

Furthermore, a Future Innovation Division will be newly established to respond to medium- to long-term changes in the environment, and a Product Development Strategy Department, a New Product Development Department, a Future Business Development Department and the Non-alcoholic Department will be placed under it.

- The MUGINONE Promotion Department and the Advertising Department will be placed directly under Suntory Spirits Limited.
- In order to strengthen cooperation with Suntory Global Spirits and promote marketing activities in the Asia-Pacific region, an Asia Pacific Development Department will be newly established.
- In order to strengthen cooperation with various organizations with responsibility for companywide management, sales and profits, the organizations under the Sales Development & Marketing Promotion Division will be reorganized.
 - A Sales Management Department will be newly established, and an Off-Premise
 Sales Management Department, a Business Planning Department and a
 Nationwide Wholesale Account Sales Department will be placed under it.
 - The functions of the Food Service Business Planning Department will be transferred to a newly established On-Premise Sales Management Department.
