Notice Concerning Transfer of Consolidated Subsidiaries' Shares

Suntory Beverage & Food Limited (SBF) hereby announces that it has come to an agreement with UCC ANZ MANAGEMENT PTY LTD (UCC), a subsidiary of UCC Holdings Co., Ltd., to transfer all the shares in Suntory Coffee Australia Limited, which operates fresh coffee business mainly in Oceania.

1. Reasons for the Transfer of Shares

As a result of our continuous and comprehensive portfolio review, SBF has been considering how to further grow our fresh coffee business and now has decided that this is best achieved under new ownership, who could maximize the growth potential of the business. Therefore, SBF has come to an agreement to transfer all the shares in Suntory Coffee Australia Limited to UCC.
