Notice Concerning Establishment of a Subsidiary for the Full-line Beverage Service Business

Suntory Beverage & Food Limited (the "Company") hereby announces that it has resolved at a meeting of its Board of Directors held today to establish Suntory Beverage Solution Limited ("New Company") as a new subsidiary of the Company, and to start operation of the vending machine business, fountain business, and water business ("Full-line Beverage Service Business") currently operated by the Company's consolidated subsidiary Suntory Foods Limited ("Suntory Foods") at the New Company on April 1, 2016 (planned).

1. Purpose for Establishment of New Company and Transfer of Full-line Beverage Service Business

The Full-line Beverage Service Business operated by Suntory Foods for the purpose of providing a full-line of beverage services will be transferred to the New Company via the company split method in order to expedite decision making regarding this business within the Group, to improve customer satisfaction, and to increase management efficiency. Moreover, the Group aims to accelerate the expansion of its customer base even further by unifying its strategy to further enhance customer response capabilities and sales capabilities, as well as providing high added value to customers through the development of new products and services.
